# WHAT IS ETIAS?

According to the European Union, the ETIAS or European Travel Information and Authorization System is a mandatory entry requirement for visa-exempt travelers visiting any of the 30 European countries. It is electronically linked to the traveler's passport and remains valid for up to three years or until the passport expires, whichever comes first. You must apply for a new ETIAS travel authorization if you get a new passport. The system is due to start in Q2 2025.
